*In 2021, the Ontario government passed legislation to shift the responsibility of collecting and processing residential Blue and Grey Box material from towns / cities to producers. Producers design, create and market Blue and Grey Box products and packaging. As of Jan. 1, 2024, Niagara Region will no longer have operational and financial responsibility for the residential Blue and Grey Box program.
