PRESENTATION

 Responsive Region Improvement Team Lean Introduction

Randy McDougall, Continuous Improvement Leader, provided an overview of the process Lean follows. He advised that "Lean Thinking" is a methodology that is the most effective Continuous Improvement approach because it is grounded in process thinking and a proven science (the elimination of the 7 wastes). Mr. McDougall highlighted the five critical concepts of Lean: Specify Value; Identify the Value Stream; Make the Value "Flow"; "Pull" to Customer Demand and Pursue Perfection.
