PRESENTATIONS

2. <u>Jungbunzlauer Canada Inc.</u>

Sharon Grant, Vice President, Finance & Administration and Bob Maunsell, Engineering Manager, Jungbunzlauer Canada Inc., attended to provide background information on their organization and to speak to their proposed warehouse addition. Jungbunzlauer is one of the world's leading manufacturers of Citrics, Xanthan Gum, Gluconates and Specialties and Special Salts. Ms. Grant described the products and the production sites, highlighting the Port Colborne Facility. Mr. Maunsell described the existing three warehouses and presented a detailed plan of warehouse #4 apprising Committee of the reasons for the warehouse addition.

The presenters requested the same consideration offered by the City of Port Colborne – capping the development charges at 5,000 square feet. The presenters also requested the Region to accelerate the anticipated incentives which will be contained within a future municipal and regional industrial CIP.

Moved by Councillor Joyner Seconded by Councillor Badawey

That the presentation and requests by Jungunzlauer Canada Inc. be referred to staff for further information regarding a legal opinion with respect to capping the development charges at 5,000 square feet as offered by the City of Port Colborne; accelerating the anticipated incentives which will be contained within a future municipal and regional industrial CIP; and suggestions/options to assist Jungunzlauer Canada Inc.; and

That this report be presented, for consideration, to the Integrated Community Planning Committee on February 23, 2011.
