

In addition to the Technical Report responses summarized in Table 1, the following is an update on the status of a number of ongoing issues that the Project Team is working on resolving.

A. Biederman Road

Waterford is continuing to work with the Township of Wainfleet to finalize the purchase of Biederman Road.

B. Archaeological Clearances

We have been working closely with staff from MCM and MNRF to ensure the appropriate protection of archaeological sites within the proposed Law Quarry Extension License Boundary.

The MCM Clearance letter will be provided to the Township and Region when available.

C. ARA Licence Application

We are continuing to work with MNRF to address their Site Plan comments. MNRF has confirmed that they do not have any outstanding Natural Environment of Hydrogeology comments.

Next Steps:

There have been <u>no pubic comments</u> received on this Application for a Quarry Extension.

We trust that this response will address the outstanding JART comments on the Law Crushed Stone Quarry Extension Application.
