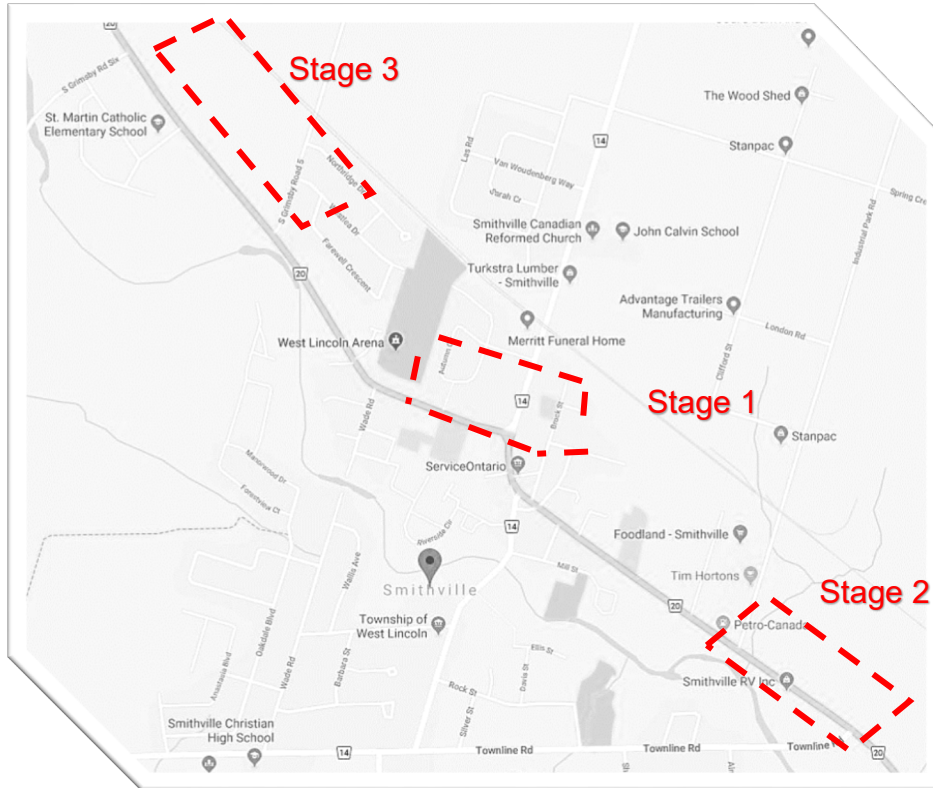


NOTICE OF PUBLIC INFORMATION CENTRE

Road Reconstruction of Regional Road 20 (West Street) Between South Grimsby Road 6 and Griffin Street and Road Reconstruction of Regional Road 20 (St. Catharine Street) Between Industrial Park Road and Townline Road In the Township of West Lincoln

Niagara Region will be undertaking rehabilitation and improvement works along Regional Road 20 (West Street) between Grimsby Road 6 and Griffin Street and along Regional Road 20 (St. Catharine Street) between Industrial Road and Townline Road, in the Township of West Lincoln. Works for this project will be completed over three stages beginning in July 2019 and reaching completion in October 2020.

- Stage 1 works will occur in 2019 and include: road reconstruction of West Street and Regional Road 14 (Station Street) intersection and road works, including the installation of a traffic signal at Station Street; road resurfacing and roadside improvements including sidewalk improvements along Regional Road 20 between Wade Street and Station Street; improved pedestrian safety through proper crosswalks at Wade Street; and a new parkette and gateway feature at Smithville Square
- Stage 2 works will occur in spring 2020 and include: road resurfacing and roadside improvements on St. Catharine Street; and the installation of a roundabout at St. Catharine Street and Townline Road.
- Stage 3 works will occur in summer 2020 and include: road reconstruction of West Street between South Grimsby Road 6 and South Grimsby Road 5; and the installation of a roundabout at South Grimsby Road 6.
