This **CONFIDENTIAL** application is for Niagara Region households generating diaper waste resulting in a need to set out additional garbage. You may apply for a waste exemption only if you are unable to accommodate diaper waste within your garbage limit, or cannot hold on to the diaper waste for a two week period.

If you have children under four years of age in diapers, live in either a single family home or in an apartment with six units or less, and currently receive curbside collection provided by Niagara Region, you may qualify for an exemption. If the application is approved, you may set out clear bag(s) of diaper waste for collection on your curbside collection day.

This application must be renewed annually for continued service.

Check which situation(s) apply to you:

One child under four years of age in diapers. If approved, one clear bag of diapers can be placed at the curb on the opposite week of your regular garbage collection week, without a garbage tag.

Two children under four years of age in diapers. If approved, one clear bag of diapers without a garbage tag can be placed at the curb for collection weekly.

Three or more children under four years of age in diapers. If approved, two clear bags of diapers without garbage tags can be placed at the curb for collection weekly.

1. All applications are acknowledged. If the application is approved, you may set out:
 - **One child under the age of four:** One clear bag of diapers can be placed at the curb on the opposite week of your regular garbage collection week, without a garbage tag.
 - **Two children under the age of four:** one clear bag of diapers without a garbage tag is allowed each week;
 - **Three or more children under the age of four:** two clear bags of diapers without a garbage tag are allowed each week;
 - This exemption is for diaper waste in clear bags only, and no other garbage shall be placed in the clear bags. Bag weight cannot exceed 22.7 kg (50 lbs.).
2. Weekly participation in Niagara Region's Blue/Grey Box and Green Bin programs is required under the Waste Management By-law. Check your Collection Guide, call the Waste Info-Line at **905-356-4141** or **1-800-594-5542**, or visit the website at **niagararegion.ca/waste** to find out more information about these programs.
3. Regular household garbage will only be collected every-other-week on my regular collection day.
4. This application must be renewed annually on the service anniversary date. Please note the date of application before for your records. A renewal reminder will be sent to you prior to the expiry of this service.
5. If the service is no longer required or there is a change of address, I will notify Niagara Region.
